- Please **GET ACTIVE WITH THE WA WA SHRINERS** this year. I hope to be able to say Hello to many of you at our upcoming events.

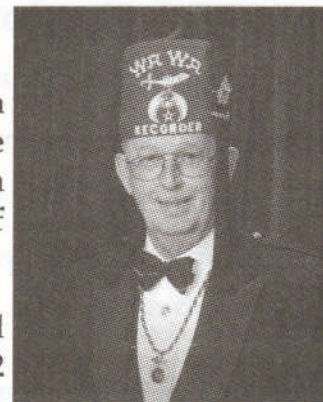

PUBLIC RELATIONS REPORT

MONTREAL, Thursday, April 17, 2008 – This morning, Mr. Gary Morrison, Chairman of the Board of Governors, Shriners Hospitals for Children (SHC) – Canada announced that the Joint Boards responsible for Shriners Hospitals for Children throughout North America have approved the construction of a new SHC facility. This facility will be built on the dedicated 5 acres located at the southwest corner of the McGill University Health Centre's (MUHC) Glen Campus in Montreal.

The Joint Boards are comprised of the two boards that govern both the Shriners fraternity and the Shriners Hospital for Children system of 22 hospitals. This formal decision was moved during a regular quarterly meeting of the Joint Boards based on a unanimous recommendation of the Planning Committee that has been working on the file since last July. It shows the support of Shriners leadership for the project.

"This is a tremendous step and we are very excited about moving forward", comments Mr. Morrison. He goes on to say "we will ensure that the new facility will be defined by the necessary specifications to correspond to our vision and the needs of our patients".

The Hospital is grateful for the continued support it has received from patients and their families, the public, the Friends of the Shriners, the McGill University Health Centre (MUHC), McGill University, the Government of Quebec, and the City of Montreal.

To enhance our Development and Donor Relations program, Shriners Hospitals for Children has hired Directors of Development, (thirteen at present), based in several of our Hospitals. These professional fundraisers in no way, however, replace our Imperial Donor Relations Committee or the Donor Relations Chairmen at our Shrine Temples. In fact, the success of this growing program is only possible through the coordination of efforts and working together.

Major Donor Support and Solicitation

The Directors of Development actively seek new donors and assist interested parties in fulfilling their philanthropic intentions. They research potential donors and follow-up with donors who have contacted our organization about making a major or planned gift. They also seek to have information distributed to Shriners and others about planned giving opportunities. As a liaison to Shriners Hospitals Headquarters staff, they are able to work with donors on sophisticated giving vehicles.

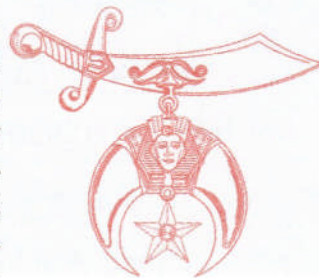
Donor Relations Support

CINCINNATI SHRINER'S HOSPITAL**THEY REALLY LOVE THEIR JOB**

How often do you hear someone say "I really love my job" and mean it? If you spend any time with the nurses at the Shriners Hospital for Children – Cincinnati, you'll hear that phrase a lot. Nursing opportunities range from special training for the transport team, working on the acute care unit, serving as the primary nurse on the rehab floor or a member of the outpatient department.

Nurses on the hospital's transport team are the first contact a family makes with our staff. Being able to answer questions, encouraging a parent to hold their child's hand and even repeating medical information are small ways to reassure a parent their child is getting the very best care. "Supporting families during this time of crisis and caring for a critically ill child are important to me" says Conchi Madsen, R.N., a member of the transport team and a nurse on the acute care unit.

When a new patient arrives at the hospital, they are admitted to the acute unit on the third floor. Here a team of more than 15 staff assess and stabilize the child. A nurse signs up as the child's primary and is assigned to this child for their entire hospitalization. As the primary caregiver, the nurse is there for the family and child on a daily basis. This helps lessen some of the stress from the hospital experience and provides a constant and familiar face for the child and family.

Nurses who work on the rehabilitation unit see a variety of patients. In a given week, 25 or more children are scheduled for reconstructive procedures, such as scalp expander removal, a release and graft or a laser treatment. The primary nurses keep their parents on a daily schedule starting with breakfast, bath time, therapy sessions, off to the school room and then up to the fifth floor café for lunch. There's always time for the playroom, another physical therapy session and maybe a nap and then it's time for dinner. The nurses also spend time reviewing the home care plan and teaching families how to care for their child once they return home. Providing the very best in continuity of care, children return to the hospital for outpatient follow up visits on a regular basis. The nurses in the outpatient department are equal partners of the burn team. It is during the clinic visit the family can describe how things are going at home. If pressure garments need to be revised, if there's a problem at school or if a child is having an issue with night time itching, the nurse notes this in the chart and has the physician talk with the family. Clinic families and the nursing staff form a strong bond over the years. These nurses know which children need a pep talk to keep up with their exercises and which kids will tell them about their latest soccer game.

Most nurses here will tell you that although some days are long and can take a lot out of you, they wouldn't give it up for the world. "Watching the way kids can recover from such a devastating injury and get back with their lives is remarkable", says Donna Mertens, R.N., nurse manager of the outpatient department. "These families have a hard road in front of them for a long time, but they keep on going. It makes doing my job pretty rewarding

Providing Pediatric Specialty Care

The Shriners Hospitals specializing in orthopaedic conditions are committed to providing specialized medical and rehabilitative services to children with congenital deformities and conditions, orthopaedic injuries, and diseases of the neuromusculoskeletal

system. 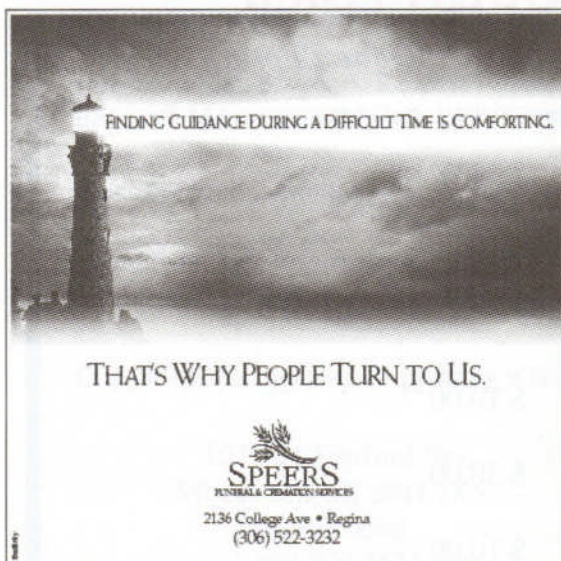
