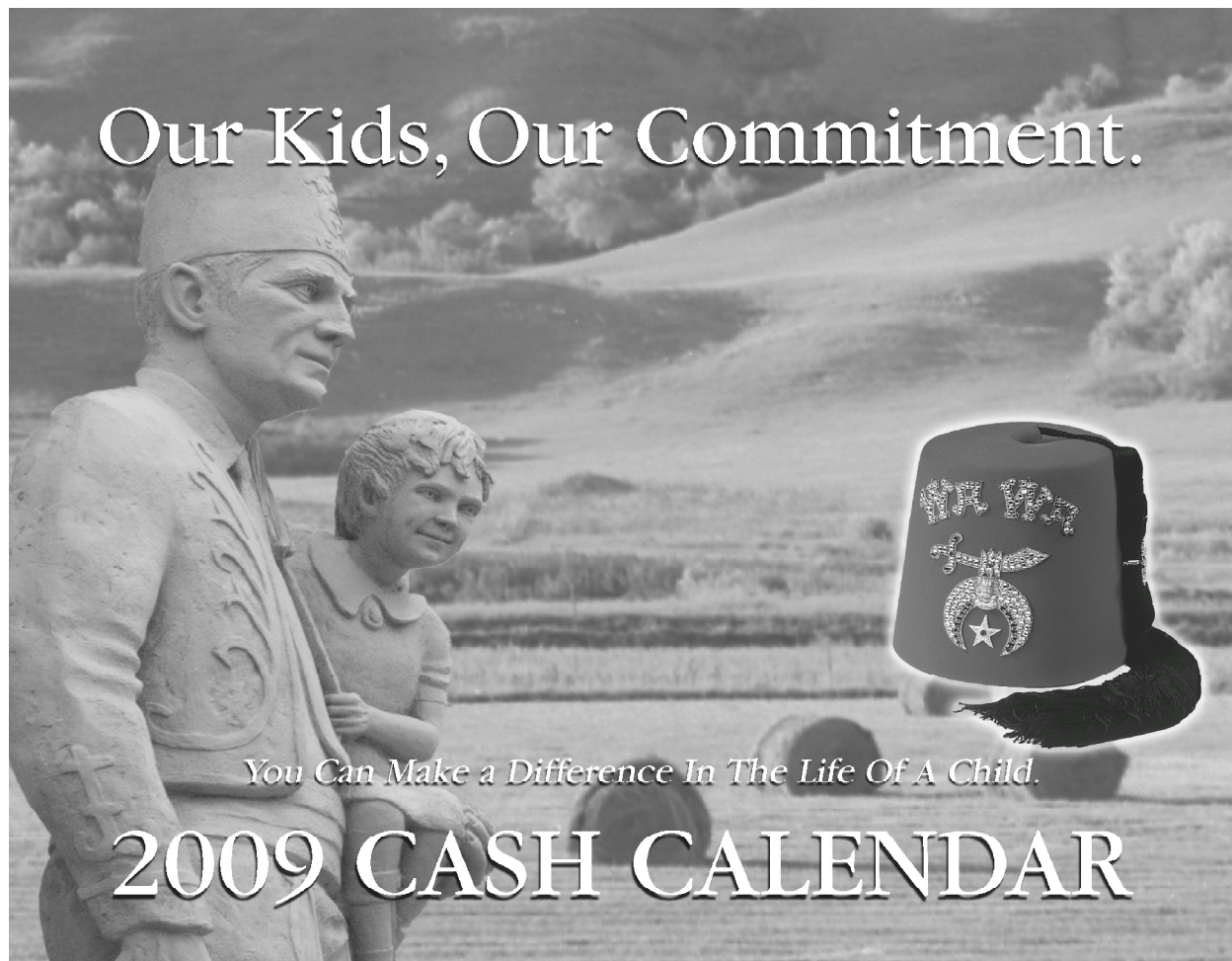

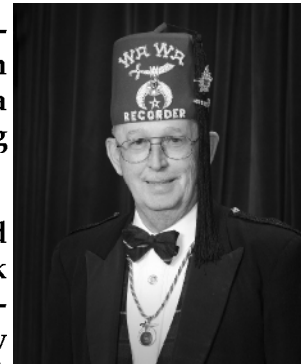

PUBLIC RELATIONS REPORT

A Variety of Shriners Events Raises Millions for Hospitals

Shriners throughout North America donate their valuable free time to hold a variety of special events each year to benefit Shriners Hospitals for Children. These events provide an important contribution by helping to fund the hospitals and raising awareness about the Shriners fraternity and its philanthropy.

In 2007 alone, 522 events held by Shriners temples raised more than \$14.1 million for Shriners Hospitals. While some temples sponsored fundraisers like newspaper crusades, rodeos, dances, and golf and fishing tournaments, others hosted events that are a bit out of the ordinary.

For the past 36 years, the Jackson Hole Shrine Club in Wyoming, which is affiliated with Kalif Shriners, has

held cutter horse races to benefit Shriners Hospitals for Children — Salt Lake City. During the two-day event, held each February, 40 teams compete in a series of races down a snow-covered track. A cutter is similar to a horse-drawn chariot, with two wheels on each side. One person sits on the cutter and directs the two-horse team during the race.

Each year, the races draw between 3,000 to 5,000 spectators and raise between \$17,000 and \$20,000, said Bob Zimmer, president of the Jackson Hole Shrine Club. Funds to benefit the hospital are raised through Calcutta betting, an auction-style type of wagering where people continue to “buy” teams at higher prices throughout the event.

Zimmer, who is also the Teton County sheriff, admits that organizing the cutter races each year can be time consuming, but he believes it is well worth the effort. “When you see one youngster who has had the benefit of receiving care at Shriners Hospitals, it puts it all in perspective.”

In Spokane, Wash., El Katif Shriners race about 10,000 bright-yellow ducks down the Spokane River to raise funds for the Shriners Hospital in their city each year. The ducks aren’t alive, though — they’re plastic.

Members of the community sponsor the ducks by buying raffle tickets. Ticket numbers are affixed to the bottom of each duck. On race day, a crane lifts a container filled with the ducks high above the river and dumps them in all at once. The ducks float about a mile down the river to the official finish gate. Sponsors of the first five ducks to finish the race win prizes.

About 500 people attend the duck race every year, said John Robertson, an El Katif Shriner and coordinator of the 2008 race, which will be held on September 21. Last year’s duck race raised \$33,500. Since 1991, El Katif has donated a little more than \$533,000 in race proceeds to the Shriners Hospital in Spokane and to the temple’s patient transportation fund.

Robertson has volunteered to work on the event since becoming a Shriner five years ago. “It’s rewarding to me as a Shriner, because it shows the community that we are fortunate enough to have a Shriners Hospital in Spokane,” he said.

Thanks to the efforts of Shriners who volunteer to work on events like these, more than 865,000 children each year receive one-of-a-kind medical care — at no charge — at the 22 Shriners Hospitals for Children.

Dear Sir;

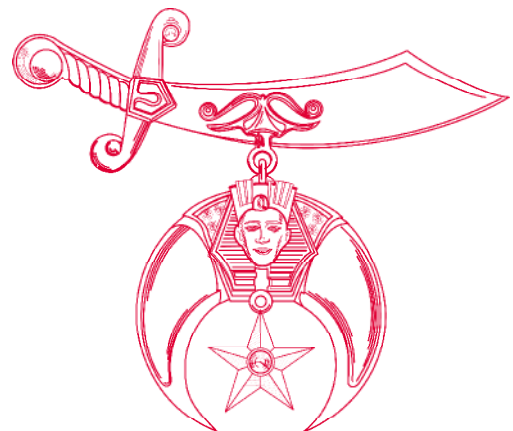
Initiation Fees

As one can see, in this example WA WA is actually subsidizing the Candidate and his Lady by \$183.00.

One is the Great Sand Hills of Southwest Saskatchewan and the other picture is a hay field with bales which was taken in the QuAppelle Valley, on number 6 Highway north of Regina. The incorporation of the Shriner and the Child into the scenery depicts our motto which is "Our Kids, Our Commitment". The backdrop for all the calendar pages is also a picture of hay fields which were taken in the same area.

Many thanks go out to Craig Clendening and his Company, "Camera One" for the work he did in helping to produce the calendar format. Some of the areas he worked on includes selecting the areas to be photographed, doing the actual photography, supplying the pictures and the arrangement of them which includes incorporating the picture of the Shriner and the child. I sat down with Craig and gave him some of our ideas and he came up with the rest. Thanks Craig for a job well done.

The Calendars will be shipped out to the Shrine Clubs the first week in October and they will also go on sale the first week in October.

The selling price of the calendars will be \$20.00 each, and there will be 365 Winners. There will be 5 draws for \$1000.00, 48 draws for \$100.00 and 312 draws for \$25.00. The odds are very good as we will only sell a maximum number of calendars namely 4200. The draws are all made on January 18 \ 09 at the Shrine Temple under the supervision of a Government appointed Auditor. The winners will be published in the Warblings .

This is a very good fund raiser for your Shrine Club as you receive \$4.00 per calendar sold which is like a 20% commission. We sold 3700 calendars last year so lets go for 4200 this year. This is only a 13.5% increase. Remember once you have sold someone a calendar they are an easy sell next year.

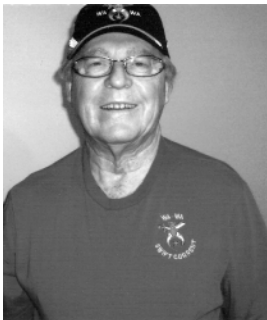

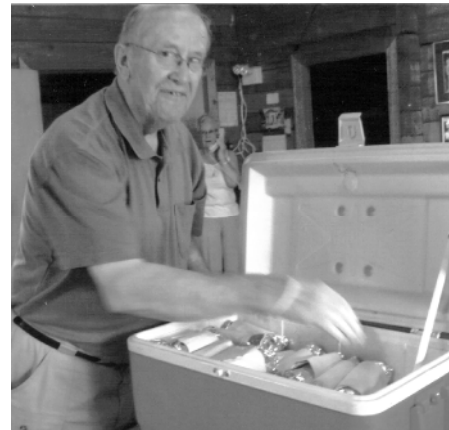

INTRODUCTION

Because Shriners have been the driving force behind Shriners Hospitals for Children, it has become natural to associate the Fez with this charity. However, the Shrine of North America and Shriners Hospitals are separate and distinct legal corporations.

Shriners Hospitals for Children is incorporated in the state of Colorado, and it operates 22 hospitals. Its purpose is to provide medical care to children with disabilities without regard to race, creed, sect or nationality. The treatment for the children is provided at no cost. This is the Charitable corporation.

The Shrine of North America is incorporated in the state of Iowa, and it presently has 191 unincorporated fraternal associations in Canada, Mexico, the United States and Republic of Panama. We know them as Shrine Temples. This is the Fraternal corporation.

A study done by Shriners International Headquarters found that Shrine Temples conduct more than 2,000 fundraising activities annually. Many of these fundraisers are strictly for the Temples – and this is perfectly acceptable. Other fundraising activities are for the benefit of Shriners Hospitals for Children – and this is also perfectly acceptable.

However, the individual purchasing a ticket, product, etc., or the donor, should be advised, in advance, how the proceeds will be used. This pamphlet is intended to provide guidance to the Temples, units, clubs and Nobles in their fundraising activities so there can be no criticism directed at them that the solicitation did not conform to the requirements of the law or was deceptive or misleading.

TYPES OF FUNDRAISERS

There are two types of Shrine fundraisers – Charitable and Fraternal.

CHARITABLE FUNDRAISERS – Where 100 percent of the net proceeds benefit Shriners Hospitals for Children. (See pages 3-5.)

FRATERNAL FUNDRAISERS – Where the net proceeds benefit the Temple, which in turn may distribute them as it sees fit. For example, profits may be disbursed to the Temple general fund, a building fund, to clubs and/or units, to Shriners Hospitals for Children, to local community or Masonic related projects (DeMolay, Masonic Home, etc.) or any combination thereof. [See pages 4-5].

PROCEDURES THAT APPLY TO ALL SHRINE FUNDRAISING ACTIVITIES

All fundraising must comply with the law of the land; that is, the law of the jurisdiction where the activity takes place. This includes national, state or province, and local laws.

The use of the name Shriners Hospitals is governed by §503.10 of the bylaws of Shriners Hospitals. All fundraising is governed by General Orders as may be issued on that subject by the Imperial Potentate.

Insurance. Your attention is particularly called to that portion of the existing General Order #1 pertaining to insurance. Strict compliance is required.

All contracts must be reviewed and approved by the Temple Potentate after receiving the advice of the Temple attorney.

All fundraising promotional materials (including Temple publications) must include a statement indicating the major entity benefited by the funds [Statement of Purpose].

STATEMENTS OF PURPOSE

All fundraising promotional materials must contain a STATEMENT OF PURPOSE. Below are examples for each type of fundraising activity.

FOR CHARITABLE FUNDRAISERS:

"Net proceeds from this (activity, event, etc.) are for the benefit of Shriners Hospitals for Children."

FOR FRATERNAL FUNDRAISERS:

"Net proceeds from this (activity, event, etc.) are for the benefit of XYZ Temple/Unit/Shrine Club."

DISCLOSURE (for Fraternal fundraisers) "Payments are not deductible as charitable contributions."

NOTE: All fraternal fundraising materials must include both the statement of purpose and disclosure.

2 CHARITABLE FUNDRAISERS

It should be emphasized at this point that a Noble (in his capacity as a Shriner), a Shrine Temple/club/unit, an organization of Nobles, or affiliated/appendant corporations SHALL NOT engage in any charitable fundraising effort other than for the benefit of Shriners Hospitals for Children.

When a decision is made to conduct a charitable fundraiser, the responsible Noble (club/unit president, committee chairman, etc...) must submit a written request to the Temple Potentate having jurisdiction thereof. If he approves, the Potentate must then obtain the written consent of the Imperial Potentate and Chairman of the Board of Trustees. This request shall be sent to the Executive Vice President – Imperial Council, Shriners International

Headquarters, P.O. Box 31356, Tampa, Florida 33631-3356. Final approval for a charitable fundraising activity is effective upon the Temple's receipt of a Charity Activity Form. If a request is denied by the Imperial Potentate and Chairman of the Board of Trustees, the Temple Potentate will receive a full explanation in writing.

One hundred percent of the net proceeds from charitable fundraisers must be given to Shriners Hospitals for Children.

Expenses for operating the event must be actual, and no labor charges can be made for volunteer work by Shriners and/or their families. Under certain conditions, existing General Orders allow the use of a portion of funds raised for the hospitals to be used for patient transportation.

All solicitation materials, tickets, programs and documents must include factual information (Statement of Purpose) regarding use of the proceeds. [See figure 1.]

Information about our hospitals (obtainable from the Imperial Public Relations Department), such as patients success stories, facts and figures, photos or other appropriate material, may be used in programs for **charitable** fundraisers. [See figure 2.]

The Temple shall report the results of each charitable fundraising activity within 60 days of the activity to Shriners Hospitals for Children on the Charity Activity Form provided to the Temple. A Temple that fails to remit the net proceeds within 60 days of the activity shall be assessed interest retroactive to the date of the activity. The Temple shall maintain detailed financial records of all fundraising activities involving Nobles, clubs, units, organizations of Nobles or affiliated/appendant corporations for a period of seven years. Details of all revenues and disbursements shall be maintained in such financial records.

State Solicitation Laws: Some states have solicitation laws that may require Shrine compliance. Temples must have their attorney review such laws. By way of example, the State of Florida requires that the following statement be included in all printed solicitation materials, receipts, written confirmation, or reminders of contributions soliciting charitable contributions for Shriners Hospitals. The statement must be conspicuously displayed in all capital letters.

SHRINERS HOSPITALS FOR CHILDREN ARE DULY REGISTERED WITH THE STATE OF FLORIDA AS REQUIRED BY ITS SOLICITATION OF CONTRIBUTIONS ACT. THEIR REGISTRATION NUMBER IS CH 433. A COPY OF THE OFFICIAL REGISTRATION AND FINANCIAL INFORMATION MAY BE OBTAINED FROM THE DIVISION OF CONSUMER SERVICES BY CALLING TOLL-FREE 1-800-435-7352 WITHIN THE STATE. REGISTRATION DOES NOT IMPLY ENDORSEMENT, APPROVAL OR RECOMMENDATION BY THE STATE.

SHRINERS HOSPITALS FOR CHILDREN

FRATERNAL FUNDRAISERS

A Noble (in his capacity as a Shriner), or a Shrine Temple/unit, or an organization of Nobles or affiliated/appendant corporations must obtain the prior written consent of the Temple Potentate having jurisdiction thereof before engaging in any fundraising activity. There can be no representation, express or implied, that the proceeds will be for the benefit of Shriners Hospitals for Children.

When the Potentate gives his written consent for a fraternal fundraising activity, a copy of the same shall be mailed to the Executive Vice President – Imperial Council. Further, any printed materials pertaining to the fundraising activity shall be sent to Executive Vice President, Imperial Council if so requested.

All promotional material, tickets, programs and documents must contain a Statement of Purpose and Disclosure. [See figure 3.] Information about our hospitals may be used in programs for fraternal fundraisers *provided that each contains the appropriate Statement of Purpose and Disclosure*. This information must appear in a conspicuous location used lettering bold enough to be easily read. Programs and other 'booklet' type materials must include the Statement of Purpose and Disclosure on the front cover or the first page. [See figure 4.]

The Statement of Purpose and Disclosure should also be included as a part of each fundraising activity advertised in Temple publications. The Temple shall maintain detailed financial records of all fundraising activities involving Nobles, clubs, units, organizations of Nobles or affiliated/appendant corporations for a period of seven years. Details of all revenues and disbursements shall be maintained in such financial records.

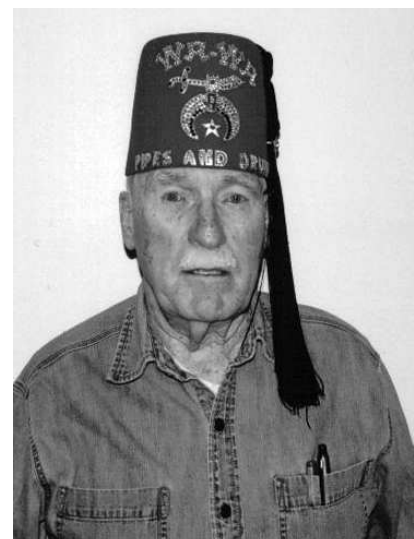

CHILDREN TO GROWN-UPS...MAKING THE TRANSITION

Historically, patients with massive burn injuries did not survive. Until recently, survival has been the only key measure of a successful outcome for a seriously injured burn patient.

But as more patients survive large burn injuries, the burn team's focus shifted to quality of life issues and offering patients a chance at a productive life. Services that address the physical, psychosocial and vocational needs of burn survivors are more important than ever before.

About 14 years ago, the Cincinnati Shriners Hospital developed a plan to include a "transitions program" for young adult burn survivors. The process began as a multidisciplinary committee. As responsibilities of the group and patient involvement increased, the hospital dedicated a full-time transitions coordinator to organize the program.

Under the leadership of Lori Anderson-Stevens, our transitions program evolved from school re-entry visits and summer burn camp to a comprehensive program with the focus on providing adolescents with additional resources.

Currently over 900 teens and young adults are served by our hospital. The services offered from this program include resources to assist the needs of this population. By finding out how to job search on the internet, how to get health insurance, how to interview for a job, or where to get vocational training the transitions program help these teens take the first steps into adulthood.

Transitions recently expanded their services to include a quarterly newsletter "Teen Connection," a transitions booklet, an assessment tool and a resource center at the hospital.

Lori and staff continue to identify patients who could benefit from these services. The resources assist in the psychosocial recovery as well as in their navigation into adulthood.

Our patients have come a long way and with the help of transitions, there is no limit to the possibilities that lay before them. The best outcome for all of us is a happy, healthy, and "ready to take on the world" young adult burn survivor.
