

Power of Attorney Act changes in Saskatchewan

A change to legislation governing Powers of Attorney in Saskatchewan was recently introduced. Through consultations, the government of Saskatchewan identified gaps in the existing legislation with respect to the financial and property management for vulnerable adults who may become incapacitated *or* are otherwise unable to manage their own affairs. The government hopes that the amendments to the Power of Attorney Act will close the gaps.

Summary of changes under the Powers of Attorney Amendment Act, 2014 include:

- Accounting Requiring an attorney to provide a final accounting in a prescribed format, to
 interested parties including, if the Grantor is deceased, to the executor or administrator of the
 grantor's estate and the public guardian and trustee;
- Fees Under the "old" Act an Attorney for property could charge a 'reasonable' fee. Under the "new" Act the Power of Attorney can charge a fee if it is set-out in the enduring Power of Attorney or, by Court Order or, failing that, the Attorney may charge the following fees:
 - (a) 2.5% of the money received by the property attorney on behalf of the grantor per month; (b) 2.5% of the payments made by the property attorney on behalf of the grantor per month.
- Gifts Under the "old" Act there was no direction for gifts but under the "new" Act, attorneys may make a gift from an estate if a) the power of attorney document specifically permits it, or b) if the attorney has reason to believe the property owner would have done so, provided in this later situation, the total value of all gifts made in a year does not exceed \$1000.
- New PGT (Public Guardian and Trustee) Powers Giving the Public Guardian and Trustee the power to investigate an attorney's management of an estate.







Ken's Safety Corner

SUN SAFETY TIPS

To keep you and your child safe, you should:

- Cover up. Wear light-coloured, long-sleeved shirts, pants, and a wide-brimmed hat made from breathable fabric. When you buy <u>sunglasses</u>, make sure they provide protection against both UVA and UVB rays.
- Limit your time in the sun. Keep out of the sun and heat between 11 a.m. and 4 p.m. When your shadow is shorter than you, the sun is very strong. Look for places with lots of shade, like a park with big trees, partial roofs, awnings, umbrellas or gazebo tents. Always take an umbrella to the beach.
- Use the UV Index forecast. Tune into local radio and TV stations or check online for the UV index forecast in your area. When the UV index is 3 or higher, wear protective clothing, sunglasses, and sunscreen.
- Use sunscreen. Put sunscreen on when the UV index is 3 or more.
- **Drink liquids (especially water).** If sunny days are also hot and humid stay cool and hydrated to avoid heat illness. Dehydration is dangerous and thirst is not always a good indicator of how often you should drink liquids.
- Avoid using tanning beds. If you do use them, understand the risks and learn how to protect yourself.

Sunscreens are not meant to increase the amount of time your child can spend in the sun. They are only meant to increase their Protection when they have to be outside.

- **Choose a high SPF.** Protect your health by using a broad-spectrum sunscreen with a Sun Protection Factor (SPF) of at least 15. The <u>sunscreen</u> should also say "broad-spectrum" on the label, to screen out most of the UVA and UVB rays.
- Look for "water resistant". Look for claims on the label that the product stays on better in water ("water resistant", "very water resistant").
- **Read application instructions.** For best results, be sure to follow the instructions on the product label. Use the recommended amount of <u>sunscreen</u>.
- **Apply it early.** Apply sunscreen 20 minutes before you go outside; re-apply 20 minutes after going outside and at least every 2 hours after that. Use a generous amount. Cover exposed areas generously, including ears, nose, the tops of feet and backs of knees.
- **Re-apply often.** Re-apply sunscreen often to get the best possible protection especially if you are swimming or sweating heavily.
- **Protect yourself.** Sunscreen and insect repellents can be used safely together. Apply the sunscreen first, then the insect repellent.
- **Sunscreens and babies.** Do not put sunscreen on babies less than 6 months of age. Keep them out of the sun and heat as their skin and bodies are much more sensitive than an adult's.
- **Test for an allergic reaction.** Before using any tanning product on you or your child check for an allergic reaction, especially if you have sensitive skin. Apply it to a small patch of skin on the inner forearm for several days in a row. If the skin turns red or otherwise reacts, change products.



This group consists of both active and retired Nobles who have served 5 years in a unit and reached 50 years of age. All active Nobles may become members at 55 years of age.


We keep up to date on events, local and international, and have guest speakers and Divan/Unit reports. There are no annual fees.

1. What is Shriners International?

The worldwide organization is a fraternity based on fun, fellowship and the Masonic principles of brotherly love, relief and truth. There are nearly 200 temples located throughout the world.

2. What is Shriners Hospitals for Children?

Our unique health care system, which has 22 locations in three countries, is dedicated to improving the lives of children by providing pediatric specialty care, conducting innovative research, and offering outstanding teaching programs for medical professionals. All care and services are provided regardless of the families' ability to pay.

3. What is Shriners International's connection to Shriners Hospitals for Children?

The fraternity founded and continues to support the health care system as its official philanthropy.

4. Where does the money come from to operate Shriners Hospitals for Children?

As a 501(c) (3) non-profit organization, Shriners Hospitals for Children relies on the generosity of Shriners, corporations and the general public to carry out its mission and improve the lives of children every day.

5. What percentage of the Shriners Hospitals for Children operating budget is spent in direct support of the organization's three-part mission of patient care, research and education?

Approximately 85 percent.

7. When was the first Shriners temple (chapter) established?

Mecca Shriners was established in New York City in 1872.

8. Why does Shriners International have a Near Eastern theme?

Similar to college fraternities that use the Greek motif, Shriners International selected Near Eastern iconography and regalia to serve as the fraternity's theme when it was founded in 1872. The Shriners' red fezzes (hats) and the costumes they sometimes wear in parades pay tribute to this long-standing tradition.

9. When and where did the first Shriners Hospitals for Children open?

We opened our first hospital in 1922, in Shreveport, LA. The hospital initially focused exclusively on treating the orthopaedic conditions and after effects of the polio virus, which was rampant at that time?

10. What are some examples of the orthopaedic conditions treated at Shriners Hospitals for Children today?

Our health care system provides treatment for a full range of congenital and acquired orthopaedic conditions. The most commonly treated conditions include clubfoot, limb deficiencies, deformities and discrepancies, scoliosis (curvature of the spine), osteogenesis imperfect (brittle bone disease), and orthopaedic difficulties associated with neuromuscular disorders such as spina bifida and cerebral palsy.

11. What are the principal service lines offered at Shriners Hospitals for Children?

Our care disciplines are pediatric orthopaedics, burns, spinal cord injuries, and cleft lip and palate.

12. When did Shriners Hospitals for Children begin to provide burn care?

Our locations specializing in treatment of burns and burn-related injuries have been leaders in burn care and research since opening in the mid-1960s.

13. What are some examples of expertise in burn care found at Shriners Hospitals for Children?

Our hospitals that treat burns and burn related injuries provide comprehensive acute, reconstructive and rehabilitative care. In addition, a multi-disciplinary team provides support to the patients and families as they transition back to school and family life.

14. When did Shriners Hospitals for Children begin to provide care for spinal cord injuries?

In the early 1980s, Shriners Hospitals for Children opened the nation's first spinal cord injury rehabilitation centers specifically designed for children and teens.

15. What are some of the rehabilitative programs and services offered to patients with spinal cord injuries at Shriners Hospitals for Children?

Available programs include a complete range of therapies, psychosocial guidance, fitness programs and experiential activities to build independent living skills.

16. What criteria determine a child's eligibility for care at Shriners Hospitals for Children?

Children up to age 18 are eligible for care at Shriners Hospitals for Children if there is a reasonable possibility they can benefit from the specialized services available. Acceptance is based solely on a child's medical needs.

17. How does someone schedule an appointment or refer a patient to Shriners Hospitals for Children?

Pre Authorized Membership Dues Payment Plan

WA WA Temple has implemented an Automatic Dues Payment Program for annual membership dues. This program is being recommended and adopted by more and more temples throughout North America, as a method to reduce administrative costs and thereby keep our membership dues as low as possible.

If you already are having any utility bills or other bill payments being done by direct withdrawal from your bank account, then you are already familiar with this concept. For those of you who are not familiar with this process, the basics are that a noble will grant permission for the Temple to withdraw quarterly payments throughout the year and subsequent years, directly from a nobles bank account in order to pay for annual WA WA membership or PCM dues as stipulated in the Temple bylaws.

Members may enroll at any time during the year. Payments would commence in the first possible quarter (March, June, September, December) and the first payment would depend on the date enrolled. For example – assuming 2014 Member dues \$96.00 (as per Temple Bylaw's).

Subsequent year's membership dues would be deducted on the last banking day of March, June, Sept, and Dec 31 at an amount equal to one quarter of the annual dues for the upcoming calendar year as per Temple Bylaws.

All electronic information is retained ONLY on the Bank of Nova Scotia secure website – no electronic banking information is maintained on any WA WA computer. The signed authorization forms will be stored in a safety deposit box at the Bank of Nova Scotia

To enroll in this plan, please sign the form on the at the end of this issue and return to the Recorder along with a voided cheque. If you no longer use cheques, your bank can supply you with a Pre Authorized Payment form that can be sent to us.

For those of you who are wondering why payments through credit cards are being discouraged, it is due to the fact that the administrative costs plus credit card processing costs far exceed the currently purposed method.


